NOTICE IS HEREBY GIVEN THAT THE GOVERNING BODY OF THE CITY OF BALLINGER WILL MEET AT 5:30 P.M. ON **JULY 1, 2019** IN REGULAR SESSION AT ITS REGULAR MEETING PLACE IN THE CITY HALL, 700 RAILROAD AVENUE IN THE CITY OF BALLINGER, TEXAS FOR THE FOLLOWING PURPOSES:

4. The City Council will have a public hearing to hear citizen input on the proposed Charter amendments to be placed on the November 2019 ballot.
5. Any citizen who desires to address the City Council on a matter not included on the agenda may do so at this time. Per the open meeting act, the City Council may not deliberate on items presented under this agenda item. All presentations are subject to a five (5) minute time limit.
6. The City Council may consider, discuss and authorize a service contract with Hibbs & Todd Engineering.
7. The City Council may consider, discuss and authorize the joint election contract with Runnels County for the general election on November 6, 2019.
8. The City Council may consider, discuss and authorize the Veteran's day parade for November 11, 2019.
9. The City Council may consider, discuss and authorize the opening of bids for employee health insurance coverage for the fiscal year 2019-2020.
10. The City Council may consider, discuss and authorize the purchase of property located at 509 S. Broadway, legal description Lot 6, Block 65- Original Addition.
11. The City Council may hear the monthly police activity report from Chief Stanley Maresch.
12. Consider approval of building permits.
13. Hear the City Administrator's bi-weekly report.
